Dr. Heike Alps, LL.M. (Chuo-University, Tokyo) is a lawyer specialized in labour law. She is experienced in the communication with Japanese clients and wrote her doctor thesis about ADR in Japan.

Dr. Karin Angerer is Head of the division for civil procedure law, alternative dispute resolution and insolvency law at the Bavarian Ministry of Justice. She began her legal career in 1993 and has been a judge at several Bavarian courts and a national expert at the European Commission.

Prof. Dr. Moritz Bälz, LL.M. (Harvard) holds the Chair of Japanese Law at Goethe University Frankfurt, where he also serves as Executive Director of the Interdisciplinary Centre for East Asian Studies (IZO). Until 2008, he worked as attorney with Freshfields in New York and Frankfurt. He has published widely on topics of Japanese business law.

Prof. Dr. Winfried Bausback has been Bavarian Minister of State for Justice since 2013.

Anke Beyer is a German qualified lawyer, Solicitor (England & Wales), Mediator BM®, BAFM & Mediation Trainer BM®, BAFM and Supervisor. Since 2003 she is working as a mediator in business and family conflicts and as a mediation trainer at the Chamber of Commerce in Munich and Frankfurt, at the EBS and at the Mediation Institute IMS e. V.
